7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Medical Mutual of Ohio (Express Scripts) to serve as the pharmacy benefits**
9 **manager and to operate the mail-order pharmacy program on behalf of the County, for a**
10 **one-year term, from 1/1/16 through 12/31/16, at an administrative cost not to exceed \$0.75**
11 **per prescription, with two options to renew for an additional one-year term, for the**
12 **Executive's Department of Law, Insurance and Risk Management, and declaring an**
13 **emergency.**

15 WHEREAS, the Board of Control, at its meeting held on 9/9/15, awarded a professional
16 service contract with Medical Mutual of Ohio (Express Scripts) to serve as the County's
17 pharmacy benefits manager and to operate a mail-order pharmacy on behalf of the County, for a
18 one-year term, from 1/1/16 through 12/31/16, at an administrative cost not to exceed \$0.75 per
19 prescription, with two options to renew for an additional one-year term, subject to confirmation
20 by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned professional service contract with Medical Mutual of Ohio (Express
24 Scripts) is necessary and in the best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
27 State of Ohio, that:

29 SECTION 1

31 The award by the Board of Control of a professional service contract with Medical
32 Mutual of Ohio (Express Scripts) to serve as the pharmacy benefits manager and to operate the
33 mail-order pharmacy program on behalf of the County, for a one-year term, from 1/1/16 through
34 12/31/16 at an administrative cost not to exceed \$0.75 per prescription, with two options to
35 renew for an additional one-year term, is hereby confirmed and the Executive is authorized to
36 execute such professional service contract.

40 This Resolution is hereby declared an emergency in the interest of the health, safety, and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 authorize the Executive to execute a professional service contract with Medical Mutual of Ohio
43 (Express Scripts) so that the County has a pharmacy benefits manager and mail-order pharmacy
44 in place when the current professional service contract expires on 12/31/15.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
