7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract to TC Architects for miscellaneous design, drafting, and technical assistance on an**  
9 **“as needed” basis, in an amount not to exceed \$30,000.00, for the County Executive’s**  
10 **Administrative Services- Division of Physical Plants, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held September 16, 2015, awarded a  
13 professional service contract to TC Architects for miscellaneous design, drafting, and technical  
14 assistance on an “as needed” basis, in an amount not to exceed \$30,000.00, subject to  
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the aforementioned professional service contract with TC Architects is necessary and in the  
19 best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract to TC Architects for  
27 miscellaneous design, drafting, and technical assistance on an “as needed” basis, in an amount  
28 not to exceed \$30,000.00, is hereby confirmed and the County Executive is hereby authorized to  
29 execute such construction contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide design, drafting, and technical assistance for the Executive’s Administrative Services-  
36 Division of Physical Plants.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.


