7 **A Resolution authorizing the County Executive to execute a sixteen-month policing**
8 **contract with the County of Summit Developmental Disabilities Board, to provide three**
9 **Sheriff's Deputies, one Sheriff's Detective and two vehicles, for the period 9/1/15 through**
10 **12/31/16, for the amount of \$288,618.90, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the County of Summit Developmental Disabilities Board ("DD Board") and
13 the DD Board wishes to enter into a sixteen month policing contract with the County of Summit
14 to provide three Sheriff's Deputies, one Sheriff's Detective and two vehicles, for the period
15 9/1/15 through 12/31/16; and

17 WHEREAS, the DD Board has agreed to pay the County the amount of \$17,718.56 per
18 month or \$70,874.24 annually in 2015, and \$18,145.39 per month or \$217,744.66 annually in
19 2016, for a total of \$288,618.90 for the sixteen-month term of the contract, from 9/1/15 through
20 12/31/16; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned policing contract with the DD Board is necessary and in the best interest
24 of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that;

29 SECTION 1

31 The County Executive is hereby authorized to execute a sixteen-month policing contract
32 with the County of Summit Developmental Disabilities Board, to provide three Sheriff's
33 Deputies, one Sheriff's Detective and two vehicles, for the period 9/1/15 through 12/31/16, for
34 the amount of \$288,618.90. The DD Board has agreed to pay the County the amount of
35 \$17,718.56 per month or \$70,874.24 annually in 2015, and \$18,145.39 per month or \$217,744.66
36 annually in 2016, for a total of \$288,618.90 for the sixteen-month term of the contract, from
37 9/1/15 through 12/31/16.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of the County of Summit and for the further purpose of immediately
43 providing necessary policing to County of Summit Developmental Disabilities Board effective
44 9/1/15.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
