8 **contract for the cost of a social worker assistant assigned the Federal Fiscal Years 2015-**
9 **2016 Family Drug Court Implementation Project grant, for the period 10/1/14 through**
10 **9/30/16, in a total amount not to exceed \$110,976.00, for the Court of Common Pleas-**
11 **Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held on September 16, 2015, awarded
14 professional services contract for the cost of a social worker assistant assigned to the Federal
15 Fiscal Years 2015-2016 Family Drug Court Implementation Project grant, for the period of
16 10/1/14 through 9/30/16; and

18 WHEREAS, this Council finds and determines after reviewing all pertinent information
19 that the contract is necessary and is in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award of the Board of Control of a professional service contract for the cost of a
27 social worker assistant assigned to the Federal Fiscal Years 2015-216 Family Drug Court
28 Implementation Project grant, for the period 10/1/14 through 9/30/16, in a total amount not to
29 exceed \$110,976.00, is hereby confirmed and the County Executive hereby authorized to execute
30 such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety, and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for a Family Drug Court service provider.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
