7 **A Resolution confirming an award by the Board of Control of a purchase order with**

26 The award by the Board of Control of a purchase order with Accent Draperies, to furnish
27 and install manual and motorized window shades at 1180 South Main Street, Akron, Ohio, at
28 State Term Pricing, in an amount not to exceed \$48,200.00, is hereby confirmed and the County
29 Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the aforementioned window shades at 1180 South Main Street, Akron, Ohio.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
