7 **An amended Ordinance amending Chapter 177 of the Codified Ordinances of the County**
8 **of Summit to make certain updates and revisions to the purchasing process of the County,**
9 **for the Executive's Department of Finance and Budget, and declaring an emergency.**

11 WHEREAS, the County Executive has recommended certain revisions to Chapter 177 of
12 the Codified Ordinances of the County of Summit, entitled "Board of Control; Contract
13 Procedures;" to update and revise certain purchasing practices of the County; and

14
15 WHEREAS, such updates and revisions should improve efficiencies in the County's
16 purchasing process and align Chapter 177 with current practices of the County, best practices of
17 governmental contract procurement, and updated provision of the Ohio Revised Code concerning
18 purchasing by counties; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to amend Chapter 177 of the
22 Codified Ordinances of the County of Summit as recommended by the Executive;

24 NOW, THEREFORE, BE IT ORDAINED, by the Council of the County of Summit,
25 State of Ohio, that:

29 Chapter 177 of the Codified Ordinances of the County of Summit is hereby amended as
30 set forth in amended Exhibit A, attached hereto and incorporated herein by reference.




34 The Ordinance is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason of immediately
36 amending Chapter 177 in order to immediately update, revise and streamline certain purchasing
37 processes of the County

41 Provided this Ordinance receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
43 and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.
