7 **A Resolution ratifying the Columbine Service Area Sanitary Sewer Improvement Project**
8 **Q-948, as approved in Resolution No. 2015-271, in Springfield Township and the Village of**
9 **Mogadore, for the Executive's Department of Environmental Services, and declaring an**
10 **emergency.**

12 WHEREAS, this Council approved the detailed plans, specifications and tentative
13 assessment for the Columbine Service Area Sanitary Sewer Improvement Project Q-948
14 ("Project") in Resolution No. 2015-271; and

16 WHEREAS, this Council conducted a hearing on October 5, 2015 at 4:30 p.m., where
17 objections to the Project, the tentative assessment, or to the boundaries of the assessment district
18 were to be heard; and

20 WHEREAS, the County Executive received correspondence signed by several residents
21 opposed to the Project prior to the hearing, yet no objections to the Project were made at said
22 hearing, nor were written objections received by this Council to the Project in the 5 day period
23 after the hearing; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 including minutes of the aforementioned hearing, the detailed plans, specifications, estimate of
27 cost and tentative assessment of the Project, that the Project as approved in Resolution No. 2015-
28 271 should be ratified;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The Columbine Service Area Sanitary Sewer Improvement Project Q-948 ("Project") and
37 the character and termini thereof, the boundaries of the assessment district, and the tentative
38 assessment which shall be levied and collected to pay the cost of the Project as approved in
39 Resolution No. 2015-271, are hereby ratified by this Council.

43 This Resolution is declared an emergency in the interest of the health, safety and welfare
44 of the citizens of the County of Summit and for the further reason to provide for the immediate
45 construction of sanitary sewage facilities in the Springfield Township and Village of Mogadore
46 needed to abate a health nuisance.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
