7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of a Federal Fiscal Year 2016 Impaired Driving Enforcement Program**  
9 **grant from the Ohio Department of Public Safety, through its Ohio Traffic Safety Office, to**  
10 **operate an impaired driving program in Summit County, for the period 10/1/15 to 9/30/16,**  
11 **in the amount of \$46,946.80, with no local cash match requirement, and appropriating**  
12 **funds, for the Sheriff, and declaring an emergency.**

14 WHEREAS, Ohio Department of Public Safety, through its Ohio Traffic Safety Office,  
15 has awarded the County of Summit Sheriff's Office a Federal Fiscal Year 2016 Impaired Driving  
16 Enforcement Program ("IDEP") grant from the Ohio Department of Public Safety, through its  
17 Ohio Traffic Safety Office, to operate IDEP in Summit County for the period 10/1/15 to 9/30/16,  
18 in the amount of \$46,946.80, with no local cash match requirement; and

20 WHEREAS, the IDEP grant, formerly called the High Visibility Enforcement Overtime  
21 grant, has provided funding for the past 16 years to the Sheriff's Office in order to conduct  
22 impaired driving enforcement program, public awareness, and education in the County of  
23 Summit; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
26 necessary and in the best interest of the County of Summit to authorize the County Executive to  
27 execute any documents necessary to accept the aforementioned IDEP grant, and to appropriate  
28 these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 a Federal Fiscal Year 2016 Impaired Driving Enforcement Program grant from the Ohio  
37 Department of Public Safety, through its Ohio Traffic Safety Office, to operate an impaired  
38 driving program in Summit County, for the period 10/1/15 to 9/30/16, in the amount of  
39 \$46,946.80, with no local cash match requirement.

16 SECTION 5


