7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Federal Fiscal Year 2016 Safe Communities grant from the Ohio**
9 **Department of Public Safety, through its Ohio Traffic Safety Office, for a Safe**
10 **Communities Program in Summit County, for the period 10/1/15 to 9/30/16, in the amount**
11 **of \$85,000.00, with no local cash match requirement, and appropriating funds, for the**
12 **Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety (“ODPS”) through its Ohio Traffic
15 Safety Office (“OTSO”) has awarded the County of Summit Sheriff’s Office a Federal Fiscal
16 Year 2016 Safe Communities grant for a Safe Communities Program in Summit County, for the
17 period 10/1/15 to 9/30/16, in the amount of \$85,000.00, with no local cash match requirement;

19 WHEREAS, the Safe Communities grant is new to the Sheriff’s Office; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that
22 authorizing the County Executive to execute any documents necessary to accept the
23 aforementioned grant from ODPS through OTSO and to appropriate these grant funds;
