7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the State of Ohio Attorney General’s Office of a Federal Fiscal Year**
9 **2016 Victims of Crime Act grant, in the amount of \$97,542.40, with a local cash match**
10 **requirement of \$24,385.60, and a Federal Fiscal Year 2016 State Victims Assistance Act**
11 **grant, in the amount of \$3,286.10, with no local cash match requirement, both for the**
12 **period 10/1/15 through 9/30/16, and appropriating funds, for the County of Summit Court**
13 **of Common Pleas – Juvenile Division, and declaring an emergency.**

14
15 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has
16 received an award from the State of Ohio Attorney General’s Office of a Federal Fiscal Year
17 2016 Victims of Crime Act (“VOCA”) grant in the amount of \$97,542.40, with a 25% local cash
18 match requirement of \$24,385.60 to be paid from the Juvenile Court General Fund
19 administrative budget, for the period 10/1/15 through 9/30/16; and

21 WHEREAS, the Juvenile Division has also received an award from the State of Ohio
22 Attorney General’s Office of a Federal Fiscal Year 2016 State Victims Assistance Act
23 (“SVAA”) grant in the amount of \$3,286.10, with no local cash match requirement, for the
24 period 10/1/15 through 9/30/16, and for which the Ohio Attorney General’s Office requires an
25 accounting identity separate from the VOCA award; and

27 WHEREAS, the VOCA and SVAA are annual grants which help to support salary and
28 benefits for a victim advocate and a victim services coordinator, both full-time staff providing
29 advocacy services to crime victims in Summit County; and

31 WHEREAS, the Juvenile Division provides for the required VOCA grant match within
32 its annual budget; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
36 execute any documents necessary to accept the award of the aforementioned grants from the
37 State of Ohio Attorney General’s Office, and to appropriate these grant funds;
