7 **A Resolution authorizing the County Executive to advertise for bids for a five-year HVAC**  
8 **equipment full maintenance service at 175 South Main Street, Akron, Ohio 44308, for an**  
9 **estimated cost not to exceed \$140,000.00, for the Executive's Department of Administrative**  
10 **Services – Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for a five-year HVAC  
16 equipment full maintenance service at 175 South Main Street, Akron, Ohio 44308, in Council  
17 District 4, for an estimated total cost not to exceed \$140,000.00 and

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for a five-year HVAC equipment full maintenance service at 175 South Main  
24 Street, Akron, Ohio 44308, for an estimated total cost not to exceed \$140,000.00;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for a five-year HVAC  
32 equipment full maintenance service, which includes the service of heating, air conditioning, and  
33 ventilation systems at 175 South Main Street, Akron, Ohio 44308, in Council District 4, for an  
34 estimated total cost not to exceed \$140,000.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
39 of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for a five-year HVAC equipment maintenance  
41 service for 175 South Main Street, Akron, Ohio 44308, for an estimated cost not to exceed  
42 \$140,000.00.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.


