7 **A Resolution adjusting existing appropriations in the amount of \$54,000.00 within the**
8 **Prosecutor's General Fund in the 2015 operating budget, for the fiscal year ending**
9 **12/31/15, for the Prosecutor, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2014-515, which approved
12 and appropriated the 2015 operating budget for the County of Summit, which included salary
13 appropriations for the Prosecutor's General Fund for the fiscal year ending 12/31/15; and

14
15 WHEREAS, Resolution No. 2015-493, which currently pending before this Council,
16 authorizes the County Executive to execute any documents necessary to accept the award of a
17 Federal Fiscal Year 2015 Victims of Crime Act ("VOCA") grant, for the period 10/1/15 through
18 9/30/16, in the amount of \$269,402.86, with a local cash match requirement of \$67,350.73; and

20 WHEREAS, due to an increase in VOCA funding, a surplus exists within the
21 Prosecutor's Office's salary appropriations; and

23 WHEREAS, it is necessary to adjust \$54,000.00 in current salary appropriations in order
24 to provide funding for other expenses; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned adjustment of existing appropriations, in the amount of \$54,000.00 is
28 necessary and in the best interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

22 121.22 of the Ohio Revised Code.


