7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Environmental Design Group, LLC., for additional**
9 **commercial plan reviews and construction inspection task orders for 2015, in an amount**
10 **not to exceed \$55,000.00 (a 220% cumulative increase), for the Engineer, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held on December 2, 2015, awarded
14 Change Order No. 1 to a professional service contract with Environmental Design Group, LLC,
15 for additional commercial plan reviews and construction inspection task orders for 2015, in an
16 amount not to exceed \$55,000.00 (a 220% cumulative increase); and

18 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
19 that the change order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of Change Order No. 1 to a professional services
27 contract with Environmental Design Group, LLC, for additional commercial plan reviews and
28 construction inspection task orders for 2015, in an amount not to exceed \$55,000.00 (a 220%
29 cumulative increase) is hereby confirmed and the County Executive is hereby authorized to
30 execute such change order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit and for the further reason to immediately
36 provide commercial plan reviews and construction inspection task orders for the County.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.




