A Resolution authorizing the County Executive to execute an agreement with Gerald M. and Kathleen M. Stratos, in the amount of \$2,000.00, for an easement on their property, as part of the Columbine Service Area Sanitary Sewer Improvement Project (Q-948) in Springfield Township and the Village of Mogadore, for the Executive's Department of Environmental Services, and declaring an emergency.

WHEREAS, County Council previously passed Resolution No. 2015-132, which approved a professional service contract with Heritage Land Services, Inc., for easement acquisition services for twelve sanitary sewer easements, for constructing the Columbine Service Area Sanitary Sewer Improvements Project (Q-948) (the "Project") in Springfield Township and the Village of Mogadore, in Council District 8; and

WHEREAS, County Council previously passed Resolution No. 2015-271, which approved the detailed plans, specifications, estimate of cost, and tentative assessment amount for the Project; and

WHEREAS, the Board of Control, at its November 25, 2015 meeting, authorized the County Executive to execute an agreement with Gerald M. and Kathleen M. Stratos, in the amount of \$2,000.00, for an easement on their property located at 3093 Ellet Avenue, Parcel No. 5100924, in Springfield Township, in Council District 8, as part of the Project; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute an agreement with Gerald M. and Kathleen M. Stratos, in the amount of \$2,000.00, to acquire the aforementioned easement as part of the Project;
