13 WHEREAS, the County wishes to enter into a one-year professional service contract with
14 Oriana House, Inc., as a Sole Source, subject the approval of the Board of Control, to provide a
15 Recovery Coach Program, from 1/1/16 to 12/31/16, in an amount not to exceed \$270,000.00,
16 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in
20 the best interest of the County of Summit;

27 The award of a one-year professional service contract with Oriana House, Inc., as a Sole
28 Source, to provide a Recovery Coach Program, subject to the approval of the Board of Control,
29 from 1/1/16 to 12/31/16, in an amount not to exceed \$270,000.00, is hereby confirmed and the
30 County Executive is hereby authorized to execute such professional service contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide necessary recovery and support services for the residents of the County.

41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
