7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a juvenile detention behavioral health services grant from the Summit**
9 **County Alcohol, Drug Addiction & Mental Health Services Board, for the period of 1/1/16**
10 **through 12/31/16, in the amount of \$245,346.00 with no local cash match requirement, and**
11 **appropriating funds, for the Court of Common Pleas- Juvenile Division, and declaring an**
12 **emergency.**

14 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has
15 received an award from the Summit County Alcohol, Drug Addiction & Mental Health Services
16 Board of a juvenile detention behavioral health services, for the period of 1/1/16 through
17 12/31/16, grant in the amount of \$245,346.00, with no local cash match requirement; and

19 WHEREAS, the juvenile detention behavioral health services grant will help support
20 salary and benefits for two mental health social workers, four hours per month of psychiatric
21 services, related medication costs, and will help support substance abuse evaluations provided by
22 the Summit County Public Health District to children in need in Summit County;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
26 execute any documents necessary to accept the award of the aforementioned grant from the
27 Summit County Alcohol, Drug Addiction & Mental Health Services Board, and to appropriate
28 these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 the award of a juvenile detention behavioral health services grant from the Summit County
37 Alcohol, Drug Addiction & Mental Health Services Board, for the period of 1/1/16 through
38 12/31/16, in the amount of \$245,346.00, with no local cash match requirement.
