7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of federal funds by the Ohio Department of Youth Services of a 2016**
9 **Juvenile Accountability Block Grant, for the period of 1/1/16 through 12/31/16, in the**
10 **amount of \$10,000.00, with a local cash match requirement of \$50,934.00, and**
11 **appropriating funds, for the Court of Common Pleas- Juvenile Division, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Department of Youth Services has awarded a 2016 Juvenile
15 Accountability Block Grant ("JABG") of federal funds to the Court of Common Pleas- Juvenile
16 Division, for the period of 1/1/16 through 12/31/16, in an amount of \$10,000.00, with a local
17 cash match requirement of \$50,934.00, to provide for salaries and benefits of a probation officer;

20 WHEREAS, the JABG- funded probation officer will provide probation services to
21 higher-at-risk youth in order to reduce delinquency and recidivism among this population; and

23 WHEREAS, the JABG's local cash match requirement of \$50,934.00 will be provided by
24 the Court of Common Pleas- Juvenile Division's RECLAIM funds; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the award of the aforementioned grant from the Ohio
29 Department of Youth Services, and to appropriate funds in the total amount of \$60,934.00 for
30 expenditures in 2016;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 the award of a 2016 Juvenile Accountability Block Grant ("JABG") award from the Ohio
39 Department of Youth Services, for the period of 1/1/16 through 12/31/16, in the amount of
40 \$10,000.00, with a \$50,934.00 local match requirement.




