7 **A Resolution authorizing the County Executive to execute a two-year policing contract with**  
8 **Northfield Center Township, from 1/1/09 through 12/31/10, with one option to renew for an**  
9 **additional one-year term, to provide 5.5 Sheriff's Deputies, for the amount of \$524,461.50**  
10 **for the first year, for the amount of \$564,286.67 for the second year and for the amount of**  
11 **\$587,487.67 for the optional third year, for a total amount of \$1,088,748.17 during the two-**  
12 **year term of the contract, for the Sheriff, and declaring an emergency.**

14 WHEREAS, pursuant to Resolution Nos. 2005-249 and 2007-412, the County Executive  
15 executed a policing contract with the Township of Northfield Center which terminated on  
16 12/31/08; and

17  
18 WHEREAS, Northfield Center Township wishes to enter into a new two-year policing  
19 contract with the County of Summit from 1/1/09 through 12/31/10, with one option to renew for  
20 an additional one-year term, to provide 5.5 Sheriff's Deputies; and

22 WHEREAS, Northfield Center Township has agreed to pay the County the amount of  
23 \$524,461.50 for the first year, the amount of \$564,286.67 for the second year and the amount of  
24 \$587,487.67 for the optional third year, for a total amount of \$1,088,748.17 during the two-year  
25 term of the contract; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that  
28 authorizing the Executive to execute the aforementioned contract is necessary and in the best  
29 interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that;

36 The County Executive is hereby authorized to execute a two-year policing contract with  
37 Northfield Center Township, from 1/1/09 through 12/31/10, with one option to renew for an  
38 additional one-year term, to provide 5.5 Sheriff's Deputies, for the amount of \$524,461.50 for  
39 the first year, for the amount of \$564,286.67 for the second year and for the amount of  
40 \$587,487.67 for the optional third year, for a total amount of \$1,088,748.17 during the two-year  
41 term of the contract.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and  
46 welfare of the citizens of the County of Summit and for the further purpose of immediately  
47 providing necessary policing for Northfield Center Township.
