8 **A Resolution confirming an award by the Board of Control of a five-year contract with the**
9 **City of Akron for providing unleaded and diesel fuel for County vehicles, for the period**
10 **1/01/10 through 12/31/14, in the amount of \$.08 per gallon over the City of Akron's**
11 **wholesale cost, for an approximate cost of \$242,000.00 per year based upon 2008 figures,**
12 **for the Executive's Department of Finance and Budget, and declaring an emergency.**

14 WHEREAS, County Council previously approved Resolution No. 2004-497, which
15 confirmed the award by the Board of Control of a contract with the City of Akron for providing
16 unleaded and diesel fuel for County vehicles, for the period 9/16/04 through 9/15/09, in the
17 amount of \$.15 per gallon over the City of Akron's wholesale cost, for an approximate cost of
18 \$200,000.00 per year; and

20 WHEREAS, the County and Akron have agreed to a new contract, pursuant to which
21 Akron will provide unleaded and diesel fuel for County vehicles, for the period 1/01/10 through
22 12/31/14, in the amount of \$.08 per gallon over the City of Akron's wholesale cost, for an
23 approximate cost of \$242,000.00 per year based upon 2008 figures; and

25 WHEREAS, the Board of Control, at its meeting held February 3, 2010, awarded the
26 aforementioned contract with Akron for fuel, subject to confirmation by County Council; and

28 WHEREAS, County Council has determined by reviewing all pertinent information that
29 the aforementioned contract is necessary and in the best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The award by the Board of Control of a five-year contract with the City of Akron for
37 providing unleaded and diesel fuel for County vehicles, for the period 1/01/10 through 12/31/14,
38 in the amount of \$.08 per gallon over the City of Akron's wholesale cost, for an approximate
39 cost of \$242,000.00 per year based upon 2008 figures, is hereby confirmed, and the County
40 Executive is authorized to execute such contract.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit, and for the further purpose of immediately
46 authorizing the Executive to execute a contract with Akron to provide fuel for County vehicles.
