7 **A Resolution appropriating \$363,055.08 in carryover grant funds received from the**
8 **Mahoning County Commissioners for a Lead Hazard Abatement grant in the amount of**
9 **\$48,731.00 and from the U.S. Department of Housing and Urban Development (“HUD”)**
10 **for Community Development Block Grant (“CDBG”) activities, including Community**
11 **Investment funds in the amount of \$74,420.00, and HOME programs in the amount of**
12 **\$239,904.08, through 12/31/10, for the Executive’s Department of Community and**
13 **Economic Development and declaring an emergency.**

15 WHEREAS, Mahoning County Board of Commissioners awarded a Lead-Based Paint
16 Hazard Control Grant in the amount of \$180,000.00, of which \$60,000.00 was appropriated by
17 County Council through the adoption of Resolution No. 2008-122; and

19 WHEREAS, HUD has provided an award for CDBG community investment activities
20 including a demolition program which was appropriated by Council through the adoption of
21 Resolution No. 2008-485 and with an earlier carryover amount has a total of \$74,420.00 which
22 remains available; and

24 WHEREAS, HUD has provided an award for CDBG Homeowner Rehabilitation Loan
25 Program which was appropriated through Resolution No. 2008-485 and \$131,146.08 remains
26 available; and

28 WHEREAS, HUD has provided an award for CDBG Home Buyer Loan Program which
29 was appropriated through Resolution 2008-485 and \$108,758.00 remains available; and

31 WHEREAS, this Council has determined by reviewing all pertinent information that it is
32 necessary and in the best interest of the County of Summit to appropriate the aforementioned
33 funds in the amount of \$363,055.08;
