8 **A Resolution authorizing the County Executive to execute any documents necessary to accept the**
9 **award of a Violence Against Women Act ("VAWA") Grant from the Ohio Office of Public**
10 **Safety/Office of Criminal Justice Services, in the amount of \$42,442.55 in federal funding, which**
11 **requires a 25% local cash match in the amount of \$14,148.00, for the period 1/1/10 through**
12 **12/31/10 and appropriating a total of \$56,590.55 which includes the local cash match requirement**
13 **through 2010, for the Prosecutor and declaring an emergency.**

14
15 WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services has
16 awarded the Prosecutor's Office a VAWA Grant in the amount of \$42,442.55, which requires a
17 25% local cash match of \$14,148.00, for the period 1/1/10 through 12/31/10; and

19 WHEREAS, this annual funding supports a victim advocate position in order to provide
20 the mandated services to victims of crime; and

22 WHEREAS, County Council previously adopted Resolution No. 2009-469, which
23 appropriated the local cash match funding in the Prosecutor's operating budget ; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute
27 any documents necessary to accept the award of the aforementioned grant from the Ohio Office
28 of Public Safety, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 the JAG Victim Advocacy Grant award from the Ohio Office of Public Safety for the period
37 1/1/10 through 12/31/10, in the amount of \$42,442.55, with a \$14,148.00 local cash match
