7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a Justice Assistance Grant (“JAG”) Summit County Drug Unit Grant**
9 **from the Ohio Office of Public Safety/Office of Criminal Justice Services, in the amount of**
10 **\$143,164.00, which requires a 25% local cash match in the amount of \$47,721.29, for the**
11 **period 1/1/10 through 12/31/10 and appropriating a total amount of \$190,885.29 which**
12 **includes the local cash match requirement through 2010, for the Sheriff and declaring an**
13 **emergency.**

15 WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services has
16 awarded a Justice Assistance Grant (“JAG”) Summit County Drug Unit Grant, in the amount of
17 \$143,164.00, which requires a 25% local cash match in the amount of \$47,721.29 for the period
18 1/1/10 through 12/31/10; and

20 WHEREAS, this annual funding supports a County Sheriff’s captain position and
21 equipment for the Drug Unit operations; and

23 WHEREAS, the local match funding will be paid from the Sheriff’s Drug Unit checking
24 account funds; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the Executive to execute
28 any documents necessary to accept the award of the aforementioned grant from the Ohio Office
29 of Public Safety, and to appropriate these grant funds;
