7 **A Resolution confirming an award by the Board of Control of a purchase order with Metro**  
8 **Regional Transit Authority for bus passes for work mandated clients to have unlimited**  
9 **access to fixed route transportation services during the period 7/1/09 to 12/31/09, as Best**  
10 **Practical Source, in an amount not to exceed \$115,000.00, for the Executive's Department**  
11 **of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 10, 2010, has awarded a  
14 purchase order for the aforementioned bus passes, as Best Practical Source, subject to  
15 confirmation by County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase order with Metro Regional Transit  
26 Authority for bus passes for work mandated clients to have unlimited access to fixed route  
27 transportation services during the period 7/1/09 to 12/31/09, as Best Practical Source, in an  
28 amount not to exceed \$115,000.00, is hereby confirmed, and the County Executive is authorized  
29 to execute such a purchase order.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
34 welfare of the citizens of the County of Summit and for the further reason of immediately  
35 providing the aforementioned bus passes.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.


