24 The award by the Board of Control of a professional service contract with Provider
25 Gateway Corporation as application service provider for the Provider Gateway Long Term Care
26 system, for the period 2/1/10 to 12/31/10, as Best Practical Source, approved by the IT Board
27 3/16/10, in an amount not to exceed \$49,135.00, is hereby confirmed and the County Executive
28 is hereby authorized to execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.
