7 **A Resolution approving the award by the Board of Control of a purchase contract with**  
8 **LexisNexis for printed publications for the Law Library Resources Board in its operation**  
9 **of the Law Library, for 2010, in an estimated amount not to exceed \$30,499.23, as Best**  
10 **Practical Source, for the Law Library Resources Board, and declaring an emergency.**

12 WHEREAS, the Akron Law Library Association previously operated the Law Library,  
13 located on the 4<sup>th</sup> Floor of the County of Summit Courthouse; and

14  
15 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House  
16 Bill 420, which established county law library resource boards to operate law libraries; and

17  
18 WHEREAS, the County of Summit Law Library Resources Board took over operation of  
19 the Law Library on 1/1/10; and

20  
21 WHEREAS, as part of its operation, it is necessary for the Board to purchase printed  
22 publications; and

23  
24 WHEREAS, the Board of Control at its March 24, 2010 meeting awarded, subject to the  
25 approval of County Council, a purchase contract with LexisNexis for printed publications for the  
26 Law Library Resources Board in its operation of the Law Library, for 2010, in an estimated  
27 amount not to exceed \$30,499.23, as Best Practical Source; and

29 WHEREAS, contracts awarded to LexisNexis on behalf of the Law Library Resources  
30 Board for calendar year 2010 exceed an aggregate of \$25,000.00, which requires the approval of  
31 Council; and

33 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
34 necessary and in the best interest of the County to approve the award by the Board of Control of  
35 the aforementioned purchase contract to LexisNexis; and

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that:

42 The award of a purchase contract with LexisNexis for printed publications for the Law  
43 Library Resources Board in its operation of the Law Library, for 2010, in an estimated amount  
44 not to exceed \$30,499.23, as Best Practical Source, is hereby approved. The County Executive is  
45 hereby authorized to execute any documents necessary to approve the purchase by the Board of  
46 printed publications from LexisNexis. A list of the printed publications and their estimated cost  
47 is attached hereto as Exhibit A and incorporated herein as if fully restated.

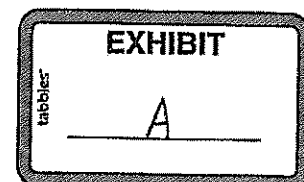
