7 **A Resolution appropriating funds in the amount of \$9,142,900.00 in the General Bond**  
8 **Retirement Fund for the Executive's Department of Finance and Budget, and declaring an**  
9 **emergency.**

11 WHEREAS, County Council Resolution No. 2010-148 provides for the issuance and sale  
12 of not to exceed \$6,000,000 of bonds of the County of Summit to currently refund a portion of  
13 outstanding bonds of the County, entitled Various Purpose Refunding Bonds, Series 1998A; and  
14

15 WHEREAS, Council Resolution No. 2010-152 provides for the issuance and sale of not to  
16 exceed \$250,000 of bonds of the County of Summit to pay costs of improving, renovating,  
17 equipping, and furnishing facilities for the Ninth District Court of Appeals; and  
18

19 WHEREAS, Council Resolution No. 2010-157 provides for the issuance and sale of not to  
20 exceed \$3,800,000 of bonds of the County of Summit to pay costs of (1) renovating the kitchen  
21 floor at the County jail, (2) acquiring, improving and equipping the intercom and door control  
22 systems at the County jail, (3) acquiring and installing door locks at the County jail, and (4)  
23 rehabilitating and renovating the County jail; and

25 WHEREAS, Council Resolution No. 2010-146 provides for the issuance and sale of not to  
26 exceed \$1,500,000 of bonds of the County of Summit to pay costs of renovating, improving,  
27 equipping, and furnishing the County Adult Probation Center; and

29 WHEREAS, Council Resolution No. 2010-154 provides for the issuance and sale of not to  
30 exceed \$1,250,000 of bonds of the County of Summit to pay costs of acquiring real property for  
31 and providing architectural design services for the County Sheriff's Administrative Building; and

33 WHEREAS, Council Resolution No. 2010-156 provides for the issuance and sale of not to  
34 exceed \$500,000 of bonds of the County of Summit to pay costs of (1) renovations and  
35 improvements to the County Courthouse and (2) installing, furnishing and equipping an evidence  
36 vault for the County Courthouse; and

38 WHEREAS, as a result of the aforementioned Resolutions, it is necessary to appropriate  
39 funds in the total amount of \$9,142,900.00 in the General Bond Retirement Fund for debt service  
40 and related issuance costs; and

42 WHEREAS, this Council has determined by reviewing all pertinent information that the  
43 appropriations included herein are necessary and in the best interest of the County of Summit;
