12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the DOES
16 Maintenance Building Roof and Lighting Upgrade Project, for an estimated total cost not to
17 exceed \$120,000.00; and

19 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of
20 Council; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that is
23 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
24 for bids for the aforementioned project;

31 The County Executive is authorized to advertise for bids for the DOES Maintenance

38 of the citizens of the County of Summit, and for the further reason that it immediately authorizes
39 the Executive to advertise for bids for the aforementioned project for DOES .

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
