12 WHEREAS, the Board of Control, at its meeting held May 5, 2010, has awarded a
13 contract for the aforementioned services subject to confirmation by County Council; and,

16 the contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a professional service contract with Summit
24 County Children Services for Family Stability Services (Kinship Care), for the period 7/1/10 to
25 6/30/11, in an amount not to exceed \$195,000.00, is hereby confirmed, and the County Executive
26 is authorized to execute such a contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety, and
31 welfare of the citizens of the County of Summit and for the further reason of immediately
32 providing such services.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
