7 **A Resolution authorizing the County Executive, on behalf of the County, to act as a partner**
8 **in the CAK International Business Park Phase 3 - Ohio Job Ready Sites Project grant by**
9 **providing sanitary sewer service to the CAK International Business Park Phase 3 as part of**
10 **the City of Green's grant application submitted to State of Ohio, Department of**
11 **Development, in Council District 8, for the Executive's Department of Environmental**
12 **Services, and declaring an emergency.**

14 WHEREAS, the State of Ohio, Department of Development, provides financial
15 assistance to local governments for the purpose of developing speculative sites for future
16 economic development opportunities through the Ohio Job Ready Sites grant; and

18 WHEREAS, the City of Green has submitted an application ("Application") to the Ohio
19 Department of Development Ohio Job Ready Sites program for financial assistance for the
20 creation of the CAK International Business Park Phase 3 in the area north and west of the Akron
21 Canton Regional Airport, and south of Greensburg Road in the City of Green; and

23 WHEREAS, the provision of sanitary sewer service to the CAK International Business
24 Park Phase 3 is a necessary prerequisite for the State to award the Ohio Job Ready Sites Grant;

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the County Executive, on
29 behalf of the County, to act as a partner in the CAK International Business Park Phase 3 by
30 providing sanitary sewer service to the CAK International Business Park Phase 3 as part of the
31 Application submitted to Ohio Department of Development by the City of Green;

SECTION 3
