7 **A Resolution appropriating funds, in the amount of \$340,000.00, from a State Fiscal Year**
8 **2011 Temporary Assistance to Needy Families grant awarded to the County of Summit**
9 **Juvenile Court by the County Executive’s Department of Job and Family Services, for the**
10 **period 7/1/10 through 6/30/11, for the Juvenile Court, and declaring an emergency.**

12 WHEREAS, the County Executive’s Department of Job and Family Services has
13 awarded a Temporary Assistance for Needy Families (“TANF”) grant, in the amount of
14 \$340,000.00, to the County of Summit Juvenile Court for the period 7/1/10 through 6/30/11; and

16 WHEREAS, Resolution No. 2010-236 approved the award of a professional service
17 contract to the Juvenile Court for its Family Resource Center, which delivers intensive case
18 management to at-risk youth and their families, as well as serving as a resource for other court-
19 involved youth and the community as a whole; and

21 WHEREAS, the professional service contract is funded by the aforementioned grant; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that it is
24 necessary and in the best interest of the County of Summit to appropriate funds for the TANF
25 grant to the Juvenile Court;
