7 **A Resolution authorizing the County Executive to execute any documents necessary to**
 8 **accept a State Fiscal Year ("SFY") 2011 RECLAIM Ohio Grant in the amount of**
 9 **\$4,224,036.08 from the Ohio Department of Youth Services, with no local cash match**
 10 **requirement, for the period 7/1/10 through 6/30/11, and appropriating \$4,224,036.08 for**
 11 **expenditures through 12/31/10, for the Juvenile Court, and declaring an emergency.**

 13 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's
 14 overburdened juvenile justice system and allows local courts to target specific areas to help
 15 divert youth from being institutionalized; and

 17 WHEREAS, the Summit County Juvenile Court has been awarded a SFY 2011
 18 RECLAIM (Juvenile Delinquent Care and Custody) grant from the Ohio Department of Youth
 19 Services, which has estimated the annual award at \$4,224,036.08, with no local cash match
 20 requirement, for the period 7/1/10 through 6/30/11; and

 22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
 23 necessary and in the best interest of the County of Summit to authorize the Executive to execute
 24 any documents necessary to accept the award of the aforementioned grant from the Ohio
 25 Department of Youth Services, and to appropriate grand funds;

 27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
 28 of Ohio, that:

 32 The County Executive is hereby authorized to execute any documents necessary to accept
 33 the SFY 2011 RECLAIM award from the Ohio Department of Youth Services, in the estimated
 34 amount of \$4,224,036.08, with no local cash match requirement.
