7 **A Resolution appropriating a Workforce Investment Act youth employment grant of**
8 **federal pass-through funds received from the County Executive's Department of Job and**
9 **Family Services for the period 7/1/10 through 6/30/11, in the amount of \$200,000.00, with**
10 **no local cash match requirement, for a year-round youth employment program through**
11 **12/31/10, for the Executive's Youth Employment for Success program, and declaring an**
12 **emergency.**

14 WHEREAS, Resolution No. 2010-269, which is currently pending before this Council,
15 confirms the award by Board of Control of a professional service contract awarded by the
16 County Executive's Department of Job and Family Services to the County of Summit Juvenile
17 Court for youth services, for the period 7/1/10 through 6/30/11; and

19 WHEREAS, the aforementioned professional service contract is funded by a Workforce
20 Investment Act grant to the Youth Employment for Success program for the period 7/1/10
21 through 6/30/11, in the amount of \$200,000.00, with no local cash match requirement, for a year-
22 round youth employment program; and

24 WHEREAS, the youth employment program's object is to assist youth in overcoming
25 barriers and achieving academic and career goals by addressing their needs for work experience,
26 academic support, leadership development, personal guidance, and follow up services; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is
29 necessary and in the best interest of the County of Summit to appropriate the aforementioned
30 grant funds, in the amount of \$200,000.00;

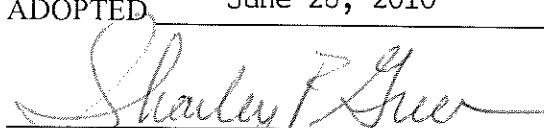
