7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept additional Workforce Investment Act (“WIA”) funds from the Ohio Department of**
9 **Job and Family Services (“ODJFS”) for the One-Stop Resource Sharing Partner**
10 **Agreement, for the period 7/1/09 to 6/30/10, in the amount of \$136,026.00, with no local**
11 **cash match requirement, bringing the total award to \$178,908.00, and appropriating these**
12 **funds for expenditures through 6/30/10, for the Executive’s Department of Job and Family**
13 **Services, and declaring an emergency.**

14
15 WHEREAS, ODJFS has provided additional WIA funds for “rent” for mandatory ODJFS
16 staffing at the Summit County Job Center, through the One-Stop Resource Sharing Partner
17 Agreement, for a program formerly known as the Ohio Bureau of Employment Services
18 (“OBES”), for the period 7/1/09 through 6/30/10, in the amount of \$136,026.00; and

20 WHEREAS, ODJFS had awarded WIA funds in an initial sharing allocation in August
21 2009 under this One-Stop Resource Sharing Partner Agreement, in the amount of \$42,882.00,
22 bringing the total sharing allocation to \$178,908.00 for state fiscal year 2010 rent; and

24 WHEREAS, these additional WIA funds are required to meet the County’s rent
25 obligations through June 2010 pursuant to a lease with Summit Workforce Solutions for space at
26 1040 East Tallmadge Avenue in Akron, Ohio; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is
29 necessary and in the best interest of the County of Summit to authorize the Executive to execute
30 any documents necessary to accept the aforementioned WIA funds from ODJFS and to
31 appropriate these grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,

38 The County Executive is hereby authorized to execute any documents necessary to accept
39 the additional Workforce Investment Act (“WIA”) funds from the Ohio Department of Job and
40 Family Services (“ODJFS”) for the period 7/1/09 through 6/30/10, in the amount of
41 \$136,026.00, with no local cash match requirement.
