7 **A Resolution appropriating carryover stimulus grant funds in the amount of \$650,788.19**
8 **for a Workforce Investment Act (“WIA”) American Recovery and Reinvestment Act of**
9 **2009 (“ARRA”) allocations award received from the Ohio Department of Job and Family**
10 **Services (“ODJFS”) for WIA Area 20, for the state fiscal year ending 6/30/10, for the**
11 **Executive’s Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the ARRA originally provided WIA funds in the amount of \$4,914,541.00
14 which was accepted and appropriated in Resolution 2009-169; and

15
16 WHEREAS, this WIA federal stimulus allocation was provided to Summit and Medina
17 Counties (Area 20) for allowable expenditures made between 2/17/09 and 6/30/10; and

19 WHEREAS, \$650,788.19 remained in purchase orders which have been subsequently
20 discharged, leaving carryover funds which require new appropriations by the state fiscal year end
21 date of 6/30/10; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that it is
24 necessary and in the best interest of the County of Summit to appropriate the aforementioned
25 funds in the amount of \$650,788.19;
