12 instructions from the Court of Common Pleas, General Division, regarding service of court  
13 orders and other documents; and

15 WHEREAS, County Council previously adopted Resolution No. 2009-469, which in part  
16 appropriated \$280,000.00, primarily for mailing and postage for the Clerk of Courts as part of  
17 the 2010 operating budget; and

19 WHEREAS, additional general funds in the amount of \$125,000.00 are necessary, in  
20 addition to the previous appropriation in the 2010 operating budget, in order to cover the  
21 increased costs of mailing services; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that the  
24 appropriation of the aforementioned funds is necessary and in the best interest of the County of  
25 Summit;
