24 for the Southwest Summit County Wastewater Study, in Council Districts 7 and 8, in an amount
25 not to exceed \$52,555.00 (17.4% increase), is hereby confirmed and the County Executive is
26 hereby authorized to execute such change order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned study.

37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
