8 **Clinic, for the period through 12/31/10, for the Court of Common Pleas, and declaring an**  
9 **emergency.**

11 WHEREAS, Resolution No. 2010-023 appropriated \$444,416.00 in funding from the  
12 County of Summit Alcohol, Drug Addiction and Mental Health (“ADM”) Board, awarded to the  
13 Court of Common Pleas Psycho-Diagnostic Clinic, to provide court-ordered evaluations in  
14 criminal cases; and

16 WHEREAS, these original appropriations were based on operational parameters used in  
17 previous years which have now changed due to staffing vacancies and improvements in  
18 operational efficiencies; and

20 WHEREAS, \$15,000.00 in original appropriations require an adjustment in order to  
21 provide services; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that the  
24 adjustment of the appropriations of the aforementioned Psycho-Diagnostic Clinic fund is  
25 necessary and in the best interest of the County of Summit;
