7 **A Resolution authorizing the County Executive to execute any documents necessary to accept an**
8 **award from the Ohio Department of Public Safety for a countywide Operating a Motor Vehicle**
9 **While Intoxicated (“OVI”) Task Force program, in the amount of \$206,392.05 in federal funds,**
10 **with no local cash match requirement, for the period 10/1/10 to 9/30/11, and appropriating all grant**
11 **funds for the period 10/1/10 through 12/31/10, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Public Safety, through the Governor’s Highway
14 Safety Office, offers funding for a countywide OVI Task Force program in the County of
15 Summit; and

17 WHEREAS, the County of Summit Sheriff’s Office has been awarded \$206,392.05, with
18 no local cash match requirement, to create a countywide OVI Task Force program to conduct
19 high visibility enforcement, public awareness, and education for alcohol-related crashes and
20 traffic-related fatalities in Summit County; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that
23 authorizing the County Executive to execute any documents necessary to accept the
24 aforementioned grant, it is necessary and in the best interest of the County of Summit to
25 appropriate the aforementioned grant funding;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

32 The County Executive is hereby authorized to execute any documents necessary to accept
33 a grant award in the amount of \$206,392.05, with no local cash match requirement, from the
34 Ohio Department of Public Safety for a countywide Operating a Motor Vehicle While
35 Intoxicated Task Force program, with no local cash match requirement, for the period 10/1/10 to
36 9/30/11.
