10 **the Executive's Department of Job and Family Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held October 27, 2010, awarded a
13 change order to provide the aforementioned services, subject to confirmation by County Council;

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the change order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of Change Order No. 1 with the International Institute
25 of Akron, Inc., for refugee social services, for the period 7/1/10 to 6/30/11, as Best Practical
26 Source, in an amount not to exceed \$78,771.00 (23% increase), is hereby confirmed and the
27 County Executive is hereby authorized to execute such change order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned change order.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
