7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Proware for the addition of an imaging module to the Proware case management system, as**  
9 **sole source, approved by the IT Board 12/7/10, in an amount not to exceed \$42,920.00, for**  
10 **the Summit County Juvenile Court, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held December 8, 2010, awarded a  
13 purchase order to provide the aforementioned module, subject to confirmation by County  
14 Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Proware for the addition of  
25 an imaging module to the Proware case management system, as sole source, approved by the IT  
26 Board 12/7/10, in an amount not to exceed \$42,920.00, is hereby confirmed and the County  
27 Executive is hereby authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and  
32 welfare of the citizens of the County of Summit, and for the further reason to immediately  
33 provide the aforementioned module.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.


