7 **An amended Resolution authorizing the County Executive to execute a renewal (1st of 2) of**
8 **a contract with AT&T, subject to the approval by the Board of Control, for wireless voice**
9 **and data services, for a two-year term, with one option to renew for an additional two-year**
10 **term, in an amount not to exceed ~~\$430,000.00~~ \$460,000.00, for the Executive's Department**
11 **of Communications, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2008-514, which
14 authorized the County Executive to execute a contract with AT&T, subject to the approval by
15 the Board of Control, for wireless voice and data services, for a two-year term, with two options
16 to renew for an additional two-year term; and

18 WHEREAS, the County wishes to execute the first of two renewals of the
19 aforementioned contract, for an amount not to exceed ~~\$430,000.00~~ \$460,000.00; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that it is
22 necessary and in the best interest of the County of Summit to authorize the Executive to execute
23 a renewal (1st of 2) of a contract with AT&T, subject to the approval by the Board of Control, for
24 wireless voice and data services, for a two-year term, with one option to renew for an additional
25 two-year term, in an amount not to exceed ~~\$430,000.00~~ \$460,000.00;

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit and for the further reason to immediately
41 provide wireless voice and data services to employees of the County without interruption.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
