7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the Ohio Department of Youth Services for an increase for the Ohio**
9 **Models for Change Mental Health Juvenile Justice Action Network grant, in the amount of**
10 **\$25,000.00, with no local cash match requirement, for the period 7/1/10 through 6/30/11,**
11 **and appropriating these funds for expenditures through 6/30/11, for the Common Pleas**
12 **Court – Juvenile Division, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Youth Services has increased amounts available for
15 the Ohio Models for Change Mental Health Juvenile Justice Action Network (“Models for
16 Change”) grant in the amount of \$25,000.00, with no local cash match requirement, for the
17 period 7/1/10 through 6/30/11; and

19 WHEREAS, this grant increases the current grant balance to a grant total of \$49,769.00
20 and funds the development and piloting of a family engagement component for the Juvenile
21 Court system to be used as a model for other communities; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that it is
24 necessary and in the best interest of the County of Summit to authorize the Executive to execute
25 any documents necessary to accept the award of the aforementioned grant from the Ohio
26 Department of Youth Services, and to appropriate these grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept
34 the increase for the Ohio Models for Change Mental Health Juvenile Justice Action Network
35 grant from the Ohio Department of Youth Services award, for the period 7/1/10 through 6/30/11,
36 in the amount of \$25,000.00, with no local cash match requirement.

20 effect and be in force at the earliest time provided by law.


