7 **A Resolution appropriating funds in the amount of \$207,680.84 in carryover balances for**
8 **2011, in various grants, for the Sheriff, declaring an emergency.**

10 WHEREAS, the County of Summit Sheriff has three grants which end 9/30/11 with
11 carryover balances from the Ohio Department of Public Safety/Ohio Traffic Safety Office,
12 including \$86,302.99 in the Operating Vehicle Intoxicated (“OVI”) Task Force grant, \$10,296.00
13 in the Law Enforcement Liaison (“LEL”) grant, and \$66,665.73 in the High Visibility
14 Enforcement Overtime (“HVEO”) grant; and

15
16 WHEREAS, the County of Summit Sheriff has a Drug Unit (“DLEF”) grant with a
17 carryover balance of \$10,733.98 and an extended ending date of 6/30/11 from the Ohio
18 Department of Public Safety/Office of Criminal Justice; and

20 WHEREAS, the County of Summit Sheriff has three federally funded Justice Assistance
21 Grants (“JAG”) from the City of Akron, with carryover balances, including \$4,028.52 in the
22 Akron 2009 American Recovery and Reinvestment Act (“ARRA”) grant, \$5,974.56 in the Byrne
23 Memorial 2009 grant, and \$23,679.06 in the Byrne Memorial 2010 grant; and

25 WHEREAS, it is necessary to appropriate these carryover funds from 2010 for 2011
26 operations; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that the
29 aforementioned appropriations, in the total amount of \$207,680.84, are necessary and in the best
30 interest of the County of Summit;
