14 consolidation of the Cuyahoga Falls Building Department into the County of Summit Division of
15 Building Standards; and

17 WHEREAS, this Council passed Resolution No. 2010-483, and approved said
18 consolidation, which included the assumption of several positions by the County of Summit; and

20 WHEREAS, this Council passed Resolution No. 2010-548, which amended the 2011
21 Staffing Report to make appropriate adjustments to certain positions for the Division of Building
22 Standards; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that the
25 increase in appropriations in the amount of \$70,600.00 in the Division of Building Standards
26 Fund is necessary and in the best interest of the County of Summit;
