7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Department of Public Safety (“ODPS”) of a Paul Coverdell**  
9 **National Forensic Sciences Improvement Act of 2000 (“Coverdell”) funding, for the**  
10 **Pathologist and Toxicologist Training grant, in the amount of \$8,829.24, with no local cash**  
11 **match requirement, for the period 10/1/10 through 9/30/11, and appropriating these funds**  
12 **for training and certification expenditures, for the period 1/1/11 through 9/30/11, for the**  
13 **Medical Examiner, and declaring an emergency.**

14  
15 WHEREAS, the County Medical Examiner has received a Coverdell Pathologist and  
16 Toxicologist Training grant award from ODPS, for the period 10/1/10 through 9/30/11, in the  
17 amount of \$8,829.24, with no local cash match requirement; and

19 WHEREAS, this funding will provide funding for travel, training, and conference  
20 expenses to various venues including the National Association of Medical Examiners  
21 Conference in Cleveland, Ohio, the American Academy of Forensic Sciences in Chicago,  
22 Illinois, the Society of Forensic Toxicologists in San Francisco, California, and an Expert  
23 Witness workshop in Naples, Florida; and

25 WHEREAS, this award will also provide funding for the certification application for the  
26 National Association of Medical Examiners; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
29 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
30 any document necessary to accept the award of the aforementioned grant from ODPS, and to  
31 appropriate these grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

38 The County Executive is hereby authorized to execute any documents necessary to accept  
39 a Coverdell Pathologist and Toxicologist Training grant award from the Ohio Department of  
40 Public Safety (“ODPS”), for the period 1/1/11 through 9/30/11, in the amount of \$8,829.24, with  
41 no local cash match requirement.


