23 The award by the Board of Control of a professional service contract with Greenleaf
24 Family Center for work activities assessment services, for the period 3/1/11 to 9/30/11, in an
25 amount not to exceed \$217,354.00, is hereby confirmed and the County Executive is hereby
26 authorized to execute such contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned services.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
