7 **A Resolution authorizing the County Executive to advertise for bids for a storm water**  
8 **system improvement project for the Village of Lakemore, for an estimated total cost not to**  
9 **exceed \$350,000.00, to be funded through the Community Development Block Grant**  
10 **("CDBG") Program, for the Executive's Department of Community and Economic**  
11 **Development, and declaring an emergency.**

13 WHEREAS, County Council previously approved Resolution No. 2008-422, which in  
14 part, approved \$500,000.00 in infrastructure improvements in the Village of Lakemore as a  
15 CDBG Project and authorized the County Executive to execute contracts with the Village of  
16 Lakemore for the same purpose; and

18 WHEREAS, the County of Summit desires to authorize the County Executive to  
19 advertise for bids for a storm water system improvement project in the Village of Lakemore, for  
20 an estimated cost not to exceed \$350,000.00 to be funded through the CDBG Program; and

22 WHEREAS, a copy of the bid specifications are on file in the office of the clerk of  
23 Council; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
26 necessary and in the best interest of the County of Summit to authorize the Executive to  
27 advertize for the storm water system improvement project in the Village of Lakemore, for an  
28 estimated cost not to exceed \$350,000.00 to be funded through the CDBG Program;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to advertize for the storm water system  
36 improvement project in the Village of Lakemore, for an estimated cost not to exceed  
37 \$350,000.00, to be funded through the Community Development Block Grant ("CDBG")  
38 Program;

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further reason that it immediately  
44 authorizes the Executive to advertise for bids for the storm water system improvement project in  
45 the Village of Lakemore, to be funded by the CDBG Program.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
