7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Northland IT Solutions, for the first renewal of two, for the Jail Management System**  
9 **maintenance agreement, for the period 7/1/11 to 6/30/12, as Best Practical Source,**  
10 **approved by the IT Board 4/19/11, in Council District 4, in an amount not to exceed**  
11 **\$47,000.00, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 27, 2011, awarded a purchase  
14 order to provide the aforementioned renewal, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

22 SECTION 1

24 The award by the Board of Control of a purchase order with Northland IT Solutions, for  
25 the first renewal of two, for the Jail Management System maintenance agreement, for the period  
26 7/1/11 to 6/30/12, as Best Practical Source, approved by the IT Board 4/19/11, in Council  
27 District 4, in an amount not to exceed \$47,000.00, is hereby confirmed and the County Executive  
28 is hereby authorized to execute such purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further reason to immediately  
34 provide the aforementioned renewal.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.

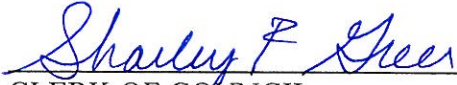

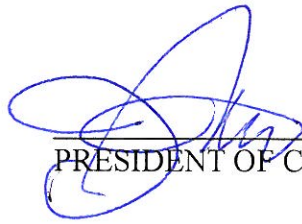
