7 **A Resolution authorizing the County Executive to advertise for bids for a one-year**  
8 **contract from 7/15/11 to 7/14/12 to provide inmate pay phone services at the County of**  
9 **Summit Jail, with three options to renew for an additional one-year term, for the**  
10 **Sheriff, and declaring an emergency.**

12 WHEREAS, the final one-year renewal of the current inmate pay phone services  
13 contract for the County of Summit Jail expires on 7/14/11; and

15 WHEREAS, the County Sheriff has requested that the County Executive be  
16 authorized to advertise for bids for a new inmate pay phone services contract for the Jail, for  
17 a one-year term, with three options to renew for an additional one-year term; and

19 WHEREAS, this Council has determined by reviewing all pertinent information that  
20 it is necessary and in the best interest of the County of Summit to authorize the Executive to  
21 advertise for bids for a new inmate pay phone services contract for the Jail for a one-year  
22 term, with three options to renew for an additional one-year term;

24 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
25 State of Ohio, that;

29 The County Executive is hereby authorized to advertise for bids for a one-year  
30 contract to provide inmate pay phone services for the period from 7/15/11 to 7/14/12 at the  
31 County of Summit Jail, with three options to renew for an additional one-year term.

35 This Resolution is hereby declared an emergency and in order to immediately  
36 advertise for bids for inmate pay phone services for the County of Summit Jail, in the interest  
37 of the health, safety, and welfare of the citizens of the County of Summit.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this council concerning and relating to  
48 the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,  
50 were in meetings open to the public, in compliance with all legal requirements, including  
51 Section 121.22 of the Ohio Revised Code.
