7 **A Resolution confirming an award by the Board of Control of a construction contract with**

14 to provide the aforementioned contract, subject to confirmation by County Council; and,

24 The award by the Board of Control of a construction contract with Kone Elevator for a
25 five-year full maintenance service agreement for elevators at the County of Summit Juvenile
26 Detention Facility, 650 Dan Street, Akron, Ohio 44310, in Council District 2, in an amount not
27 to exceed \$25,564.00, is hereby confirmed and the County Executive is hereby authorized to
28 execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned contract.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
